



DMU Electric Rates and Reliability Information

The Denison Municipal Utility board members and employees are proud of our low electric rates. American Public Power Association (APPA) conducted a 2012 kWh rate survey of all municipal utilities, investor-owned utilities and cooperatives in Iowa and DMU has one of the lowest rates. DMU's overall total revenue/kWh rate of 5.7¢ kWh is second lowest among all Iowa municipal electric providers, trailing only Muscatine Power & Water. Individually, the DMU residential rates are the third lowest, commercial rates are the #1 lowest and industrial rates are third lowest. Below is the list of surrounding utilities Rev/kWh rates from the 2012 APPA Survey:

What Can You Do With One Dollar's Worth of Electricity?

Paying for utilities isn't like shopping at the grocery store. When you buy a pound of beef, you know precisely what you are getting, but electricity can seem like just another bill to pay. Sure, you understand that electricity heats and cools your home, fuels your appliances and powers your TV and electronic devices; but what exactly are you paying for? It turns out, quite a lot.

← Here's what you can do with just a single dollar's worth of electricity:

Getting more for your electricity dollar

As you can see, your electricity dollar goes a long way. Looking to stretch those dollars further? The following are some practical measures you can take to lower your utility bills:

- Install low-flow shower heads and aerated faucets to save water and reduce water heating costs.
- Unplug charging devices after your phone or laptop is fully charged. The chargers continue to use electricity even when they are not being used.
- Replace traditional incandescent bulbs with energy-efficient compact fluorescent lamps (CFLs) or light-emitting diodes (LEDs). Energy-efficient lights use up to 75 percent less electricity and last longer.
- Use energy-saving smart strips to power off TVs, video game consoles and cable set-top boxes when they are not being used.
- Run your clothes washer and dishwasher only when they are fully loaded; partial loads waste electricity.

Making a Payment at DMU

It was discovered that sometime during the weekend of January 25th the DMU payment drop box was vandalized and all payments were stolen. We have taken precautions for this not to happen again. The drop box is more secure now and hopefully we will not have any problems again. However, for your safety and protection, please do not place cash payments in the drop box. Listed below are several different ways to make a payment:

DMU Still Under Water Watch

As you are aware, Crawford County, and more specifically, the City of Denison experienced prolonged drought conditions in 2012 and 2013. This 2 year drought has resulted in a decrease in the recovery rate of water into the eleven (11) wells Denison Municipal Utilities (DMU) uses as its water source.

To proactively try to offset the decrease in the water levels in the DMU wells and to assure we maintain adequate fire protection and an overall satisfactory water supply, the DMU Board of Trustees adopted a Water Conservation Plan that establishes measures and provisions for our customers to follow that will produce an orderly and equitable reduction in water consumption until the Board finds and declares the water shortage condition to be ended.

EFFECTIVE MARCH 1, 2013, a Water Watch condition was implemented and continues to be enforced. Under a Water Watch, all DMU water customers are directed to comply with the following standards:

- 1) No watering of lawns, shrubs or gardens between the hours of 8:00 a.m. and 8:00 p.m.
- 2) No water should be used to fill private swimming pools, children's wading pools, reflecting pools or any other outdoor pool or pond.
- 3) No water should be used for nonessential cleaning of commercial and industrial equipment, machinery and interior spaces.
- 4) No water shall be used to wash streets, parking lots, driveways, sidewalks or building exteriors.
- 5) Water should be served at restaurants only upon the request of the customer.

The following penalties apply for violations of Water Watch use restrictions imposed under this plan.

- For a first violation, the utility shall issue a written notice of violation to the water user violating the water use restrictions imposed during a Water Watch.
- For any subsequent violations within a 12 month period, a \$20 surcharge shall be imposed on the customer's water bill.

Two additional, more-restrictive conservation conditions, a Water Warning and a Water Emergency, with much more severe penalty applications, may be declared depending on the recovery rate of the DMU wells, but hopefully the drought will not linger past the spring of 2014 and DMU can lift the Water Watch declaration and again return to normal water operations.
